Please find the attached correspondence from Ms. Sandra Liscio, Chairperson, San Gennaro Festival Society of Port St Lucie, Inc., requesting City sponsorship of its Inaugural San Gennaro Festival, which will be held at the Port St. Lucie Civic Center, on September 17 and 18, 2011.
