Please find the attached correspondence from Master Officer Paul Pearson of the Ft. Pierce PAL seeking City sponsorship of the 5<sup>th</sup> Annual St. Lucie County Toy Run scheduled for December 11, 2011. The request is for the sole purpose of locating temporary signage regarding the event within the City's rights-of-way. As you know, pursuant to Section 155.07 of the City's Code of Ordinances, only City-sponsored special events may locate such signs within the City's rights-of-way.

It is important to note that this request for sponsorship comes from an organization located outside of the City; however, the event is County-wide and the City Council sponsored last year's event.

Given that "sponsorship" is a policy decision of the City Council, this memorandum serves to request that this item be placed on the next City Council agenda for consideration. 


