ORDINANCE 12-22

AN ORDINANCE RENAMING THE FOLLOWING STREET: VIA TAGLIAMENTO TO VIA VISCONTI IN TESORO PRESERVE PUD, PLAT NO. 5, NORTH OF WESTMORELAND BOULEVARD; PROVIDING FOR AN EFFECTIVE DATE.

THE CITY OF PORT ST. LUCIE HEREBY ORDAINS:

Section 1: That the following street be renamed from Via Tagliamento to Via Visconti, in Tesoro Preserve PUD, Plat No. 5, north of Westmoreland Boulevard. The subject street is depicted as Exhibit "A".

Section 2: That this Ordinance shall become effective ten (10) days after its final adoption.

Section 3: The City Clerk shall record this Ordinance with the Clerk of Circuit Court for St. Lucie County within thirty (30) days after its final adoption.




