LETTER OF OBJECTION TO NEW SOLID WASTE TAX ON RECYCLEABLE MATERIALS

I AM A FULLY DISABLED SPINAL CORD INJURY PERSON WHO LIVES
ON A FIXED SMALL SOCIAL SECURITY INCOME. I APPLIED FOR A
TOTAL DISABILITY EXEMPTION AND A HOMESTEAD EXEMPTION. I WAS
GRANTED BOTH OF THESE, BUT WAS SHOCKED WHEN I RECEIVED A
400⁰⁰ NON-AD-VALOREM PROPERTY TAX BILL, FOR THE LAST 2 YEARS
I HAVE HAD TO PAY THAT AND CAN BARELY AFFORD IT, NOW YOU WANT
TO TAX ME A ADDITIONAL 268,36? THAT MEANS I WOULD HAVE
TO PAY 668,36.

I ONLY GET 800⁰⁰ PER MONTH ON SOCIAL SECURITY DISABILITY,
I SPEND AVERAGE OF 700⁰⁰ PER MONTH ON BASIC LIVING EXPENSES,
I COULD NOT AFFORD TO PAY THIS NEW HIGHER TAX RATE, THERE
WOULD ~~HAVE~~ NOT BE ENOUGH MONEY AT YEAR END FOR ME TO PAY IT.

THIS TAX WOULD FORCE ME OUT OF MY HOUSE AND MAKE ME
HOMELESS, I WOULD HAVE TO SELL MY HOUSE AT A GREAT LOSS
OF MONEY AND MOVE. MY HOUSE HAS LOST 30% OF ITS
VALUE IN THE BAD REAL ESTATE MARKET, I WOULD LOSE ALOT
OF MONEY TO SELL AND MOVE,

IF RECYCLES DO NOT PAY FOR THEMSELVES, THEN STOP DOING IT
AND THROW THEM OUT WITH REGULAR TRASH. MANY OTHER
STATES STOPPED RECYCLES FOR THIS REASON!! IT IS BETTER
THAN IMPOSING A MANDITORY TAX TO DO IT, AND MAKING POOR
